

Returning to Jamaica

Introduction

This booklet has been designed to provide you with information that will help ease your return to Jamaica. Inside it you will find useful general information about your return, what to expect and a list of contact details of organisations that may be able to help with any resettlement related issues you encounter.



Planning for your return

The more planning that is done for your return to Jamaica, the easier it will be for you to benefit from support services when you arrive. There are a number of things to think about before you depart the UK, such as: who will meet you at the airport? Where will you stay? Can family or friends support you emotionally, financially or help you to familiarise yourself with life in Jamaica?

Before your departure, you may want to consider:

Medication

It is important to talk to your doctor before leaving for Jamaica. If you are currently taking medication, your doctor should be able to advise you on how to source further medication. It might be beneficial for you to request a letter from a GP or doctor, detailing your condition. The more information you have about your medical condition, the easier it will be to continue treatment after your arrival.

Family and friends

If you have family or friends living in Jamaica, you may wish to tell them of your arrival in case they can support you with your immediate needs upon your return. Try to take their contact details with you to the airport so that you can contact them on arrival or before you leave.

Faith-based organisations

There may be faith-based organisations in the UK that can suggest avenues of support and places of worship where you will be returning. Faith-based organisations can often provide essential basic support to those of all faiths or with no faith. A good place to start would be to contact members of your local community or faith-based leaders. It is advisable to make enquiries with these organisations or communities early on so that suitable arrangements can be made for you.

What to expect on arrival

Arrival at the airport

Once you have disembarked from the aircraft you will be taken to the airport where administrative services will be carried out for your re-entry into Jamaica.

Now that you are in Jamaica, you may want to start thinking about being reunited with family and friends, finding a job, getting a new ID and so on.



Transport

The main point of entries to Jamaica are Montego Bay's Sangster International Airport (MBJ) and Kingston's Norman Manley International Airport (KIN).

Taxis

Taxi services are available from both MBJ and KIN airports. There are two types of taxis that are available, both of which are recognised by their red licence plates.

Licensed taxis or 'contract carriages' can be expensive, but you have the option to share with other passengers to reduce the cost.

'Route Taxis' are white station wagons which have their name on the front door of the vehicle. They are a popular and affordable mode of transport in Jamaica and run along set routes, picking up and dropping off passengers along the way. Route taxis charge J\$180 to J\$300 per 50km, with short rides of around 10 minutes costing J\$130.

Buses

Kingston's municipal bus system operates large yellow buses around the country. Standard fares are from J\$100, with students, children, disabled passengers and pensioners paying half the fare. Buses and minibuses charge roughly J\$130 per 50km.



Essential information & important documents

ID cards

Jamaica's identification system is currently being updated. The new system being developed by the Jamaican government will be a digitally-based system called the National Identification System (NIDS).

At the time this booklet was published (Autumn 2021), the NIDS had not yet been put in place and other forms of ID, such as the voters ID, were still being accepted.

To be eligible for a voters ID you must:

- be aged 18 years or over and a resident or Commonwealth citizen in Jamaica
- be a resident in Jamaica at the date of registration
- have been a resident for at least 12 months prior to the date of registration
- be clear of any legal restrictions and have the capacity to make informed decisions

To apply for a voters ID:

- Visit the Electoral commission of Jamaica (EOJ) office preferably in your constituency and take your birth certificate with you.
- At the office, the registration clerk will assist you in filling out a Registration Record Card (RRC). This form is used to record your demographic information, photograph and fingerprints.
- After you have filled out the application, EOJ representatives will visit your residence at a later date to verify the address you have provided in order to complete the registration process. Once your address has been verified, your application is approved.

- The EOJ representatives will then verify your information and cross check your fingerprints to ensure there are no duplications.
- Once these checks are complete, your name is added to the voter's list and your voters ID card will be issued on May 31st or November 30th (when the next voters list is published).

Taxpayer Registration Number (TRN)

If you are a tax payer, business enterprise or organisation, you will be assigned a TRN to enable you to carry out transactions with institutions such as banks, schools and examination boards.

To apply you will need your birth certificate, a passport sized photograph, and a completed application form available from the following website: https://www.jamaicatax.gov.jm/.

National Insurance Scheme (NIS)

This social security scheme is compulsory for everyone aged 18 years and above. It offers financial protection in cases resulting in loss of income following an injury at work, incapacity or retirement. The insured person is also financially covered by the scheme in the event of their death.

To apply you will need your TRN card and a completed NIS application form available from the following website: https://www.mlss.gov.jm/.

Opening a bank account

When opening a bank account in Jamaica, you will need to provide the bank with documentation to prove your identity and residency. If you do not have the required documents specified by the bank, you may request to speak to the bank manager to discuss your individual circumstances and the possibilities of starting the process.

You may be asked to provide the following documents:

- Photo ID such as a passport or national identity card
- Documents that prove your address (rental contract or recent utility bills)
- Two passport-sized photographs
- Tax Registration Number (TRN)
- Two references (their name, contact number and occupation)
- Opening deposit (amount specified by the bank)



Driving licence

To obtain a driving licence in Jamaica, you will first need to apply for a learner's licence. To do this you must visit your local tax office and provide two passport sized photographs and pay a fee.

To obtain a full driving licence, you will be required to successfully complete a written and practical driving test. More information can be found on the following website: https://www.jamaicatax.gov.jm/motor-vehicle-driver-s-licencel.

Healthcare

Overview

Healthcare in Jamaica is free to all registered citizens and a wide range of services and care are provided at government run hospitals and healthcare facilities.

There are many hospitals and clinics in Jamaica, many of which are public institutions. Private Doctors are also widely available as long as you have the funds or insurance to cover the cost. Sexual and reproductive health

There are a large number and variety of contraceptive methods available, including condoms, birth control pills, IUDs, implants, vaginal rings and sterilisation.

Contraceptives (birth control) can be purchased over the counter across Jamaica. Emergency contraceptives are also available to purchase in Jamaica, however the cost is high and you have to ensure they are purchased from a reliable supplier.

Education & employment

Education

The Jamaican education system provides free compulsory primary education for children up to 11 years of age.

Following this, there are optional further levels of education available: secondary school (11-16 years of age), post-secondary education (16-18 years of age) and tertiary education (18 years of age and above). Tertiary education is provided through the main universities and a number of colleges.

The National Training Agency is responsible for vocational education in Jamaica. This is provided through state-run training centres and private academies. Young people aged between 15-24 years of age can access training and advice via the following organisation:




